Mowing Rochester's Historical Park

Prior to 2021, the Rochester Historical Preservation Society (RHPS) was fortunate to have a volunteer mowing the Historical Park for us. However, we contracted with a lawn company to perform the trimming around the grounds. In the fall of 2020, we learned that our volunteer could no longer perform the mowing. With no other volunteers, our Treasurer approached James Foster, Superintendent of Public Works for the Village of Rochester, about their will-

ingness to perform the mowing and trimming for the Historical Park. Mr. Foster considered it possible and prepared us a proposal/quote which we agreed to. The question was then brought before the Village Board. A resolution was passed and the RHPS entered into a contract with the Village of Rochester for the mowing. The RHPS has recently agreed to have the Historical Park mowed by the Village of Rochester again for 2022. It will be mowed the same time as the Rochester Community Park on West Main Street.






RHPS Board Seeks Society President






Nearly 2 years ago, Adam Gribbins buried the Sesquicentennial Time Capsule. Hopefully, at some point, we will be able to have proper dedication.

Rochester History: The Life Story of Lucetta Putnam Stevens West

whom I was

engaged to be



This is a version of the life story of Lucetta Putnam Stevens West that we share with the 3rd graders when they visit the Stone House during a Spring field trip. The 22 years that Lucetta spent in Rochester (1837-1859 when she died of typhoid fever) were filled with joys and sorrows, stability and changes and a time of beginnings and endings.

Welcome to this prairie town of Rochester. This is a special place to me even though it is not my birthplace. I was an Eastern girl originally, born to Benjamin

and Sally Putnam of Charlestown, New Hampshire. I am their daughter, Lucetta. You have probably heard the romantic legend that my father would not allow me to come to this developing frontier unless I had a proper stone house in which to live. Of course, out East, stone houses and stone fences are as common as the log houses and split rail fences are in this area. But, here in this developing land, it was going to be a challenge to build such a dwelling. However, my beloved Samuel Stevens, to

married, was young and determined, and he built this beautiful stone house for us. He came on ahead to get established in this new village of Rochester. He and his partners, Lewis Sargent and Samuel West were enthusiastic about this area and operated a mill to fill the needs of the pioneers. There was wonderful farm land (land that was not filled with stones and much easier to till than the land in New Hampshire and Vermont.) This presented a good opportunity for enterprising young men like my Samuel.

So, in July 1836, Samuel Stevens and I were married when he returned to Charlestown, New Hampshire. I was 19 and he was 24 years old. What an exciting time as we jour-

neved westward and came to our stone house in Rochester. Illinois. It was so different from living out East. We were 3 miles east of the village with no other houses close, but a maior road ran in front of our house. It was the stagecoach route to Shelbyville and also went on to Terra Haute, so there was always someone traveling by. Of course, my Samuel was busy buying and selling land, and involved in the development of the village. Soon my time was occupied with our new baby, Samuel Phineas Stevens who was born October, 1838; but alas within7 months my dear husband died quite unexpectedly of an illness. Not only was I burdened with grief at the loss of my husband, I was burdened with debt. Samuel had died

without a will

and with all his business dealings, he owed over \$4300.

We New

Englanders look out for one another however. My husband's business partner, Samuel West, also a Yankee, offered to accompany me back to New Hampshire with my infant son, to return to my family and to receive advice and financial assistance from my father -in-law, Enos Stevens. Knowing that I could not return to Rochester and cope as a widow with overwhelming debt and raise a baby alone, Mr. West and I were married in Unity, New Hampshire in 1840. I knew he would be able to help me with my first husband's estate and assist me in petitioning the Sangamon County Circuit Court for my widow's share. We

were aided by

the Springfield lawyer, Abraham Lincoln.
. (Perhaps you have heard of him?) He would also be valuable in helping with the sale of our possessions to raise money to satisfy the creditors.

As much as I enjoyed being with my family in the East, I had left my heart in this prairie town of Rochester and knew that we must journey back here. I persuaded my older sister, Zylpha, with her husband. Henry Kimball and their 3 year old daughter, Lucilla to join us and share in the adventure of this developing town. Plus, I had made friends in Rochester among the 25 or so families who were living here at the time
